The Stewards undersigned with the authority to rule on the matter coming from the previous Cross Country Baja World Cup Event, Baja Poland (BP), have issued a decision regarding the routine fuel analysis of the referred car and have determined in Decision N. 7 the disqualification of car N. 203 suspended ***"until the FIA Technical Working Group (TWG), of the Cross Country Commission, has investigated and taken possible decision to make any change in the regulation to follow the global availability of Diesel qualities."***

The Stewards of Baja Portalegre considered that in their decision N. 7 and the conditional suspension of it refers to a subsequent opinion of the FIA TWG of the CCR Commission, but have not give a time limit to receive an answer and settled a procedure to apply or not the above mentioned suspended Decision.

The Stewards, according with articles 11.9.2.a) and articles 14.3; 14.4.1 and 14.4.2 of ISC

## DECIDE

- To fix on **Tuesday, 1st December 2020 at 17:00 hours** to receive the opinion from the TWG on the mentioned matter and therefore apply decision N. 7.
- This final opinion must be received (received by electronic means) in writing and signed by the Chairman of the mentioned TWG and addressed to the President of the FIA CCR Commission ([ccrally@fia.com](mailto:ccrally@fia.com)).
- If this time limit expires and there is no answer from the TWG, Decision N. 7 will be applied automatically by the FIA Rally Department and car N. 203 will be Disqualified with the consequences explained in Decision N. 7 as follows:
  - (1) All competitors placed after the competitor #203, will move up by one place in the classification.
  - (2) The organizer of Baja Poland must change the final classification of Baja Poland 2020 accordingly.
  - (3) Thus, the distribution of points for the FIA Cross Country World Cup for Bajas must be amended accordingly.
  - (4) The competitor must bear the cost incurred for the procedures in the matter. Thus, they shall pay a fine of 500 €.

In accordance with Article 12.7 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <https://fiafines.fia.com/>. Any delay in making payment may entail Suspension during the period a fine remains unpaid.


