The Automobile Club of Portugal congratulates you on your will to participate at the 34<sup>th</sup> Baja Portalegre 500.

This edition is being prepared by ACP in cooperation with the Municipality of Portalegre and the Local Health Authority of Northern Alentejo, various municipalities of the district of Portalegre, the Civil Protection, PSP and GNR.

Due to the pandemic context we live in, and the need to take all precautions while organizing a world-class event such as the 34<sup>th</sup> Baja Portalegre 500, it is mandatory that all persons (team members and organization) with access to the Service Park and the Nerpor Building are tested and receive a negative result of for a SARS-CoV-2 type rRT-PCR test in the 96 hours prior to the arrival at the event.

Next week we will issue detailed information on the procedures and schedules to be adopted by the teams on how to carry out their mandatory rRT-PCR, as well as on the procedures that each Team Manager must later use to communicate to the ACP the conformity/results of the whole team.

Please be aware that it is mandatory that all teams respect the dead-lines for sending all the necessary documents and information. Should ACP not receive in due time everything that has been requested, the team might not be able to participate at the Baja. We also inform physical copies of the documents hereby requested will not be received at accreditations or administrative checks.
